

#### **Student Government Report**

Student Government President Ian Chung introduced incoming President Keith Dai, who will be reporting to the Board during the 2024-25 school year. He also shared that Spirit Week was well-received the last week of May, as well as the Vestal Music Vestival on 6/1 with numerous ensembles performing at Vestal High School in both the cafeteria and the inner courtyard. Senior activities have also been in full swing this month with the Senior Class Trip, Prom Promise Picnic, Senior Prom, and All-Nighter. As this would be Ian's last meeting with the Board of Education, he took the opportunity to thank Mrs. Restuccia, Student Government Advisor, and the students who elected him. He also thanked the Board of Education and Administration for the opportunity to participate in Board meetings. The Board wished him well as he heads to Harvard to study this fall.

#### Reports

BOE President Kathryn Egan reported on the following: --Liaison Reports: Shoba Agneshwar attended the VHE PTA meeting on 6/10. They had a Recorder Concert, as

well as an Orchestra Concert last week. The focus of the Morning Program this month is "Balance is Best". An author/illustrator visited the school earlier this month. The 5th grade Moving Up Ceremony will take place on Wednesday followed by a picnic at Arnold Park. The Senior Walk is scheduled for Monday, 6/17 with graduating seniors coming back to their elementary school building to walk the halls and remember where it all began. A pancake breakfast will be held on the last day of school. The PTA already has their sights set on fall activities and looks forward to another productive year. Eric LaClair reported on the ARE PTA meeting. They raised a lot of funds this year through PTA memberships, spiritwear, and grant applications. ARE celebrated Mental Health Awareness Day on 5/30 with many different student activities, and they will have their school Field Day on 6/13. Graduation for 5th graders will be held on 6/17. Kay Ellis reported that Dr. Jennifer Musa, BU Professor, will be visiting Tioga Hills Elementary on 6/13 to accept a \$2,500 donation the students have raised for Health for Haiti. The school will also be Zooming with Haitian students during her visit. This is a partnership that Tioga Hills has been involved in for years. Dinno Nistico encouraged BOE members to consider attending the NYSSBA Leadership in Education event on 7/19-7/20 in Albany, as he has found the information shared to be very beneficial when attending in the past.

### Superintendent Clifford Kasson reported on the following items:

--Device Task Force: Asst. Supt. for Instruction Patrick Clarke spoke to the research done by the Student Device and AI Task Force this school year. They have been focusing primarily on student device use, recommending a "pause" in student cell phone use starting at the middle school level in September 2024. Task Force committee members addressed the Board from their different viewpoints, all coming to the same conclusion that cell phones are a distraction to learning during the school day and that boundaries need to be set. Committee members who spoke included:

- 8. Gianni Cordisco, VHS Asst. Principal
- 9. Raghad Farhat, VHS Student
- 10. Reagan Young, VHS Student
- 11. Katie Balkaya, VMS Parent
- 12. Darren MacDonald, VMS Parent

A group of nine committee members (Clifford Kasson, Patrick Clarke, Gianni Cordisco, Ashley McKenna, Amy Bennett, Sonya Skinner, Darren Herman, Malinda Miller, Darren MacDonald) traveled to Newburgh City School District in early June to observe student arrival and how cell phones are sealed for the time students are in school. They found it enjoyable to hear students talking to one another and looking up as opposed to staring down at their screens. Newburgh administrators acknowledged that student mental health appears to have improved, disciplinary issues have decreased, classroom distractions have decreased, and student achievement has increased. Students actually have reported feeling happier and less stressed when they are not constantly engaged in the use of social media. Administrators did speak to the need for staff modeling when the "pause" is put into place this fall. They also spoke to the potential of instituting a cell phone "pause" at the high school the following school year. Other local area schools are also planning to implement stricter

cell phone policies this fall.

--NYSSBA President's Gavel Podcast #43: Superintendent Kasson reported that he and Andy Blaine, Director of Instruction, were honored to be invited to participate in a NYSSBA President's Gavel Podcast pertaining to the issue of student cell phone use. This podcast will be released later this month.

--Utica National School Safety Excellence Award: Superintendent Kasson shared that the Vestal Central School District was once again a recipient of the Utica National School Safety Excellence Award for 2024 at the Titanium with Honors level. This was awarded based on the school district's safety efforts to help keep students, staff, and visitors safe

--Southern Tier Robotics End-of-Season Banquet: The Robotics Club held their end-of-season banquet on 5/30, which Supt. Kasson attended. Students demonstrated their work using the new equipment provided by the District using ARP funds this past year. There are four local engineers that serve as mentors to the 30 students who participate in Robotics. It is an excellent program and both the students and mentors shared how grateful they are to the Board for the upgrades provided so that they may continue to excel

--VHS Spring Band Concert: The VHS Band performed a concert on 5/29. Superintendent Kasson was present and spoke of the excellent performance and praised Mrs. Jennifer Pham for the noticeable enthusiasm reflected in her students based on her leadership.

--Music Vestival: Supt. Kasson attended the Music Vestival on 6/1, where the inner courtyard and cafeteria were filled with music at Vestal High School. It was an informal setting with numerous musical ensembles performing throughout the day. This has become a favorite annual event.

--VHS Honors Night: Honors Night took place at Vestal High School on 6/3. Supt. Kasson witnessed 181 scholarships being awarded to Vestal seniors, totaling \$262,000. He also highlighted that \$135,000 of the total was awarded through Vestal Dollars for Scholars, which has been providing scholarships for Vestal students for the past 34 years.

--Spring Athletics Update: Mr. Kasson shared that Boys Lacrosse and Girls Softball lost in the State semifinals over the weekend, but both had fantastic seasons. Girls Golf placed 44th in the State, and four Track & Field athletes advanced to participate in the State finals.

--THE Spring Fling: Mr. Kasson shared photos he took at the Tioga Hills Spring Fling Carnival held on 6/7. The favorite event was "Pie-A-Teacher" with all proceeds being donated to the school's Health for Haiti campaign.

--Senior Prom and All-Nighter: The Prom was held at W&W Nursery on 6/8, followed by the Senior All-Nighter at Vestal High School. Mr. Kasson enjoyed participating in both events with our seniors. He shared pictures from the All-Nighter "Camp Golden Bear" themed event, including a gaming room, casino, hypnotist, and mechanical bull.
