

Governor Hochul Unveils Virtual Tour of Reimagined Greater Binghamton Airport (Full Article from Last Week)

Project Awarded \$32 Million From the Governor's \$230 Million Upstate Airport Economic Development and Revitalization Competition

Fly-Through Video Offers First Look at Major Upgrades Planned as Part of Ongoing Modernization Project

Governor Kathy Hochul today unveiled a new fly-through video rendering that offers viewers their first glimpse of a reimagined Greater Binghamton Airport. The two-and-a-half-minute video depicts the major upgrades planned for the Greater Binghamton Airport. Announced by the Governor in November, the project is being funded with \$32 million from the Governor's \$230 million Upstate Airport Economic Development and Revitalization Competition.

"Our Upstate airports are essential gateways to their local communities, and we are doing all we can to ensure they provide an easy and enjoyable welcome for residents and visitors alike," Governor Hochul said. "This new video rendering shows the dramatic transformation that is taking place at the Greater Binghamton Airport. Passengers now have the ability to see the upgrades that will make this airport the ideal welcome to all those traveling to New York's Southern Tier for everything it has to offer."

The Greater Binghamton Airport was one of nine upstate airports awarded a total of \$230 million in the latest round of the Upstate Airport Economic Development and Revitalization Competition funding announced by Governor Hochul in 2022. The awards are intended to promote, revitalize, and accelerate investments in upstate commercial passenger service airports, helping to create airports for the 21st century.

Built in 1945, the Greater Binghamton Airport handles more than 38,000 enplanements each year and is serviced by such commercial air carriers as Delta Airlines. The airport is a vital travel hub for prominent local employers, but the main terminal has not been renovated in more than two decades and its features are outdated.

Major construction is underway on both interior and exterior improvements, including:

Redevelopment of the Airport Road Approach Construction of a new canopy and entry portals Reconfiguration of the ticketing lobby and outbound baggage area

Renovation of the departures lobby and lounge Renovation of the baggage claim area and relocation of rental car counters

> New parking revenue control systems Installation of geothermal wells

The revitalization of the Greater Binghamton Airport has an estimated total cost of \$53.9 million and benefited from \$14.8 million in federal funding that was made available through the Infrastructure Investment and Jobs Act (IIJA) Airport Terminal Project. This modernization project is expected to create more than 600 jobs and be completed by the spring of 2025.

The Upstate Airport Economic Development and Revitalization Competition is administered by the New York State Department of Transportation and was open to upstate commercial passenger service airports and airports providing specialized service for commercial aircraft. Applicants were encouraged to apply for funding for a single project or a program of projects to help meet

the demands of the 21st Century. Projects submitted for review by eligible airports were evaluated based on established criteria, including but not limited to innovation in design, passenger amenities and experience, operational efficiencies, and economic effectiveness for the airport's region.

New York State Department of Transportation Commissioner Marie Therese Dominguez said, "Governor Hochul's unprecedented investments in upstate airports reflect her commitment to the economic development of communities in every region of New York State. These enhancements underway at the Greater Binghamton Airport will create a more enjoyable experience for travelers to access the airport and take advantage of the beauty of the Southern Tier – something that is plain to see in this new video."

State Senator Lea Webb said, "The Greater Binghamton Airport is a key resource for economic and community development in our region. The construction projects at the airport will enhance our region's infrastructure, making travel more efficient, accessible and supports more services which boost our local economy. I would like to express my sincere gratitude to Governor Hochul for the \$32 million investment as part of the Upstate Airport Economic Development and Revitalization Competition. These planned upgrades ensure that our airport is poised to meet the future needs of residents, visitors, and businesses in the region."

Assemblymember Donna Lupardo said, "I'd like to thank Governor Hochul for providing this visual tour of what's to come at the Greater Binghamton Airport. Construction has been underway since November, transforming our airport into a modern gateway designed to attract new carriers and passengers. We are very much looking forward to its completion next year."

Broome County Executive Jason Garnar said, "These major upgrades at the Greater Binghamton Airport are creating a modern, world-class gateway that will welcome visitors into Broome County for years to come. The new video rendering offers an eye-opening glimpse into the incredible transformation underway. Thank you to Governor Hochul for her continued support and commitment in making this transformation possible, ensuring Broome County remains a vital hub for economic growth."

The Town of Colesville lies in the northeast part of Broome County and is bounded on the north by Chenango County, on the east by the Town of Sanford, on the south by the Town of Windsor, and on the west by the Towns of Kirkwood and Fenton. The town was formed on April 3, 1821, from the Town of Windsor. Harpursville is the largest hamlet in the town although it is not incorporated.

Colesville derives its name from pioneer Nathaniel Cole, a revolutionary soldier. He settled here in 1795, on a hill south of Harpursville, known as Coles Hill. He built a tavern there which was in operation as early as 1800. It was the first tavern between Albany and Binghamton. Broome County's Nathaniel Cole Park was opened in the town in 1974 and is located about two miles from the site of its namesake's tavern.





During Hunger Action Month, Governor Hochul Launches \$10 Million Program to Increase **Food Access for New Yorkers**

Food Access Expansion Grant Program To Provide Funding for the Development and Expansion of Supermarkets, Food Co-ops, Farm Stands and More

Builds on Governor's Commitment To Enhance Access to Food in Underserved Communities, Address Affordability for New York Families and Strengthen the Food Supply Chain While Providing a Boost to New York Farmers

During Hunger Action Month, Governor Kathy Hochul today announced the new \$10 million Food Access Expansion Grant Program to help increase food access for New Yorkers living in areas without grocery stores and options for healthy, affordable food. The program will provide infrastructure funding to support the development and expansion of supermarkets, food cooperatives, permanent farm stands, and other retail food stores in underserved regions of the state while also increasing markets for New York farmers. The application period for the program opens today.

"The Food Access Expansion Grant Program will support critical projects that will help us reach our goals of offering healthy, affordable food for our families," Governor Kathy Hochul said. "Too often, families are faced with little to no options in their community to purchase fresh, local food that is also in their budget. This program will provide resources to assist with the upgrading of food stores and farm stands, and provide them with the capacity to prepare and sell locally sourced food while also supporting our farmers."

According to a report from the Office of the State Comptroller, between 2019 and 2021, approximately 10 percent of New Yorkers, or some 800,000 households, experienced food insecurity and struggled with food affordability. Grants through the Food Access Expansion Grant program will range from \$250,000 to \$3 million and will be awarded to eligible applicants for projects that increase the availability of food, whether through construction of a new retail store, the purchase of equipment to improve food and meals offered, or the creation of a mobile market and more. Examples of eligible projects include, but are not limited to the following:

Start-up, improvement or expansion of a retail food store.

Construction or upgrades of a commercial kitchen for food preparation, processing, and preservation for on-site sale or delivery.

Purchase of kitchen equipment for the preparation, preservation and sale of ready-made food and/or shelf-stable whole foods.

Construction or upgrades of retail food storage space, including cold storage expansion.

Purchase of equipment for on-site food storage, processing or handling.

Purchase of and/or expansion of retail refrigeration and market displays.

Creation or expansion of mobile markets.

Eligible entities to receive this funding include nonprofit organizations, public benefit corporations, local or regional development corporations, tribal governments, and local and municipal government agencies. Eligible applicants may partner with for-profit retailers.

New York State Agriculture Commissioner Richard A. Ball said, "Since the pandemic, the Department has focused in on addressing the gaps in the food supply chain and connecting the dots between New Yorkers and our farmers. I am heartened to see the progress we have made so far, with well more than half a dozen programs

and initiatives launched by our Governor, with support in the budget, that directly provide a boost to our farmers, reach our underserved communities, and strengthen our food system. We're proud to build on that success with the launch of the Food Access Expansion Grant program, which will help us bring healthy, affordable foods to New York families who need it most."

A webinar with additional information on the Food Access Expansion Grant Program will take place on Thursday, September 26 at 12 p.m. Registration is available online. The deadline to apply for the grant is Friday, November 22, 2024. Find additional information on funding opportunities here.

State Senator Michelle Hinchey said, "Every person, no matter their income or where they live, deserves to eat fresh, nutritious food and have an affordable place to shop for groceries in their community. Closing the gap on food insecurity is a top priority, especially in an Agriculture State like New York with a homegrown food supply as incredible as the one we have. The Food Access Expansion Grant Program will be an important tool in this fight, helping to expand food access in underserved communities across our state, including investing money back into our local farms. I thank the Governor for her partnership and look forward to seeing these grants connect the dots between locally-sourced food and families in need."

Assemblymember Donna Lupardo said, "In Broome County, and in places across the state, we are painfully aware of the many built in disparities when it comes to food access. I hope that eligible groups will take advantage of this new Food Access Expansion Grant Program. The funding can be used in a variety of ways, each designed to help communities increase the availability of fresh and healthy local food."

The Food Access Expansion Grant Program is the newest initiative in an array of programs implemented by New York State to build a more resilient food system. New York continues to support several groundbreaking programs that focus on improving access to locally grown foods through its 2025 Budget, including the Nourish NY

program, the 30 Percent NYS School Initiative for school meals, and the Farm-to School program. Additionally, this year's Budget included the second round of funding as part of the Regional School Food Infrastructure Grant Program, which provides \$50 million over five years to support regional cooking facilities that will facilitate the use of fresh New York State farm products in meal preparation for K-12 school children.

These investments build on the Governor's commitment to boost demand for New York agricultural products, bolster New York's food supply chain, and ensure all New Yorkers can access fresh, local foods. This includes the Governor's Executive Order 32 directing State agencies to increase the percentage of food sourced from New York farmers and producers to 30 percent of their total purchases within five years and raising the discretionary threshold for schools to purchase local food and food products from \$20,000 to \$150,000, a significant increase from that prior threshold.

New York State continues to prioritize increasing access to food for all New Yorkers through a number of programs and initiatives, including the enhanced FreshConnect Fresh2You initiative, the Farmers' Market Nutrition Programs and the recently announced increased benefit for WIC participants, the Urban Farms and Community Gardens Grants Programs, and more. The Department also administers the New York Food for New York Families program, a United States Department of Agriculture (USDA)-funded program that provides a boost to New York farmers, increases communities' access to local foods and further strengthens New York's food system.



Typically I write a monthly article that focuses on some aspect of Kirkwood's history with regard to a building, a person, or an event. This month I decided to use this opportunity to inform you of some of the activities that I, as your Town Historian, have been busy with that you may not know about.

One facet of my job is to collect and preserve documents. This summer I started working on a grant that will enable important Town records and other historical documents to be preserved digitally. As part of this process, I have been gathering books, diaries, pictures, journals, etc. from the Town Vault, the Historian's office, and the Kirkwood Historical Society. Each item has to be catalogued, measured, and evaluated on its condition to allow for special handling. Once this grant process is complete, the items will be removed temporarily off-site and digitally scanned. These digital documents will then be uploaded and hosted on an archive site. Following digitization, all the materials will be returned to their original locations. This process not only preserves our documents but makes them available to the public on a wider scale.

Another grant that I applied for and received this spring was from the William G Pomeroy Foundation. This grant enabled the Town of Kirkwood to get its first Historical Marker. It will be placed at School #2 in the village in the near future. It is not an easy task to get a historical designation. Each step required extensive research and proof from multiple primary sources. It was during this process of having to get fragile documents from our vault as well as from the Town of Conklin to prove the age of School #2 that made me realize just how important it is to get these items preserved in a way that is more accessible. While I was working on this Pomeroy marker grant, the

Sons of the American Revolution were also working on a Pomeroy grant of their own. My assistance was requested to help locate and identify

Revolutionary War soldiers that are buried in Kirkwood. There were 3 soldiers that were confirmed and, as a result, a Patriot Burial marker will be installed at the Kirkwood Cemetery in early September. Another facet of my job is to assist with inquiries. While I have been answering questions for several individuals, there were two families from out-of-state whom I assisted with a significant amount of genealogical research. Both of these families had descendants who were some of Kirkwood's first residents/pioneers. One family, in particular, just had their family reunion in the area in August and visited the graves of their loved ones at Brookvale. I had the pleasure of meeting with them personally, answered more questions, and gave them a tour of the area and some of the places their family had lived and frequented. Additionally, they toured the KHS School #2 Museum. They presented a slide show at their reunion and it will be added to our fam-

Lastly, from time-to-time, I am called upon to assist the Town in various ways. Most recently, it was to confirm the correct spelling of a street name, specifically Hays Avenue. There were two different spellings proposed and both the County and the Town needed to know which was correct. In my research, I discovered the Hays family moved to the area prior to 1855. I looked at maps, tax records, family trees, death records and grave sites to determine that the correct spelling was indeed Hays (and not Hayes). Further research concluded that John Hays decided to sell his family farm and develop it into the subdivision that is located there. Hays Street was named after

him. The County was also able to locate the map with the proposed "Hays Street" that was filed in 1951. This information was taken back to the Town Board so they could pass a Resolution clarifying the proper spelling which will then allow Broome County to correct it on the GIS system. The street sign will be changed back to the original spelling and not create further confusion for the residents who live there.

This is just a sample of the various aspects of being a historian. I will be traveling to Long Island September 15-18 for a State Historian Conference where I will learn about more resources, grants, and information that is available to assist me in my role in gathering, preserving and presenting our local history.

Governor Hochul Signs Legislation to Expand Health Care Access for New Yorkers

Legislation S.8486-C/A.9102-C Relates to Medicaid Reimbursement for Treatment in Place and Transportation to Alternative Health Care Settings by Ground Ambulance Services

Legislation S.6226-A/A.5789-A Provides For Availability of Ambulance Services and Advanced Life Support First Response Services to Store and Distribute Blood and Initiate and Administer Blood Transfusions

Governor Kathy Hochul signed a legislative package to ensure equitable access to essential health care and reaffirm New York's commitment to safeguarding public health and improving patient outcomes across communities.

"My Administration is committed to addressing health care disparities in our State and ensuring all New Yorkers can access the care that they need and deserve," Governor Hochul said. "This legislation ensures essential treatment and transportation, and allows New Yorkers to focus on their well-being during an emergency rather than worrying about the financial cost or availability of critical health care when they need it most."

Legislation S.8486-C/A.9102-C requires Medicaid reimbursement for ambulance services when treatment in place is administered and/or when transportation is provided to alternative health care settings instead of a general hospital

Legislation S.6226-A/A.5789-A authorizes ground ambulance and advanced life support first response services to store and distribute blood and initiate and administer blood transfusions, mirroring authorizations provided to air ambulance services.

State Senator Michelle Hinchey said, "Across New York State, EMS providers are in crisis, facing severe challenges that threaten their ability to stay open, from inadequate reimbursement to onerous rules that prevent them from delivering life-saving care as demand for their services grows. I'm proud that two of our bills directly addressing these issues are now law, finally ensuring EMS will get paid for care they're not currently reimbursed for, like on-site treatment, telemedicine, and specialized transport to mental health facilities and allowing ground ambulances to carry and administer blood transfusions to trauma patients in all emergency situations, not just between hospitals. EMS is a pillar of our healthcare system, especially in rural and medically underserved areas where getting to a hospital can take over an hour. These bills will immediately strengthen EMS and save lives, and I thank the governor for signing them into law."

Assemblymember Anna Kelles said, "Emergency Medical Services provide essential life saving care throughout the state including direct aid both on site and in transit to a medical facility. These services are especially critical in rural areas where access to hospitals may be hours away. I am grateful to Governor Hochul for signing this bill today and taking a large step towards reimbursing these brave, dedicated healthcare providers. Providing them with discretion to determine the emergency location that will best serve their patience's needs not only is common sense, but it also provides a more efficient delivery of emergency services."
