Vestal Town Board Work Session Minutes (Budget Review)

NEWSPAPER EDITED, OCTOBER 28

SUPERVISOR UPDATES:

Supervisor Sexton opened the meeting with expressing her condolences to the Nasiatka family. Robert Nasiatka was the Town Supervisor from 1992-1999 and a member of the Fire Department for 55 years.

NEW BUSINESS:

1. Budget discussions:

Supervisor Sexton stated that all the Department Heads brought their budgets back to the 2024 budget amounts with their discretionary expenditures.

The budget is now at \$703,120 over the tax cap.

Sexton states that the General Fund Balance is currently at \$3.2 million and the minimum recommendation for that fund is \$1.8 million.

Sexton stated that the Contingency Account is currently at \$75,000 and there is the possibility of lowering that to \$25,000.

Sexton stated that the Health Insurance Reserves is at \$2.6 million and should have \$1.5 million at the minimum. Sexton states that we do not want to go that low but can use some of that to offset the \$300,000 increase in Medicaid/Medicare this year.

Sexton states that NYSEG has a 7% increase this year.

The water and sewer rates will be increasing this year. The rates will increase gradually over the next few years.

Sexton stated that she will be talking with Scott Groats Water/Wastewater Superintendent tomorrow to look over their budget and try to lower their budget that is one million over the 2024 budget.

Sexton stated that she is encouraged that the 2% tax cap maybe achieved for the Towns Budget. Sexton credits all the Department Heads for their diligence and sacrifices to help keep the budget as low as possible.

The EMS will be coming on as a separate Taxing District which will increase the taxes.

Corning Runs Past Vestal

On a cool, breezy evening in Corning, the Hawks would dominate the lines en-route to a 45-6 victory.

The game, however, began well for the Golden Bears as they forced Corning to punt after three plays to start the game. Vestal quickly earned a first down, but on the next play – a 10-yard blast up the middle, the ball was fumbled away and the Hawks took over at their own 34.

Twelve plays later Corning was on the board and they would score three more times in the first half to take a commanding 30-0 lead going into intermission. The Hawks would rush for 200 yards and pass for 37 more in that first half.

The highlight for Vestal came on the sixth play from scrimmage in the third quarter. A toss from Josh Kweiler to Julian Adams in the flat saw Adams sprint down the left sideline 76 yards untouched and the Bears were on the board.

Corning would respond with touchdowns in the third and fourth quarters.

The Vestal rushing attack was stifled all evening, carrying 22 times for just 15 yards. They fared better through the air, passing for 129 yards. Kweiler would complete 4 of 9 passes for 112 yards with 1 TD and 1 interception.

With the defense on the field most of the night, J.T. Gannon and Cayden Kitchin would share tackling honors with 13. Gannon's 13 included 10 solo tackles, Kitchin had 4 unassisted.

Next: Vestal will host Union-Endicott at Dick Hoover Stadium this coming weekend in a Division II playoff game.

Golden Bears Clinch STAC Metro Title Again

The Vestal swimming and diving team improved its final dual meet record to 7-2 with an easy 90-61 win over the Binghamton Patriots. Their final record matched the team's previous best in 2013 and matched the most wins in a season in the past 30+ years. The win clinched a second consecutive STAC Metro title for the Golden Bears as they went a perfect 4-0 in the division with wins over Maine Endwell, Union Endicott, Johnson City and Binghamton. Other STAC team championships were earned by Horseheads going undefeated to win the West division, Waverly finishing undefeated in Central and Oneonta beating all three East division foes.

Both Coach Joe Shore and diving coach Sara Rostedt had athletes in some unexpected events as they looked to have the team tapered and ready for this week's sectionals. Sophie Ryan captured two events as she topped the 200 IM and the 100 Free, Reagan Young had a season best time in winning the 200 Free. Olivia Tanton captured the diving with Yi Xinn Lim finishing 2nd in her first diving competition. Yi Xinn won the 100 Fly, while Charlotte Coker topped the 500 Free.

Fran Vallone was the fastest in the 100 Back, while Yih Hui Lim swam a career best getting touched out in the 100 Breast. Yih Hui also led a 2-3-4 finish with Jay Ratterree and Vallone in the 50 Free. Vestal had 1-2 sweeps in six of the nine individual events. Key 2nd places in those sweeps included Eva Grenchus (200 Free), Keira DeVantier (IM & 500), Jia Parikh (Fly) and Megan Jones (100). Among the notable swims were season bests by Maya Stankevich in the 200 Free and 100 Back and first swims by Sarah Mahi in the 50 and 100 Free.

Yih Hui, Jones, Parikh and Ratterree opened the meet with a win in the 200 Medley relay, while Yih Xinn, Sua Choi, Young and Ratterree captured the 200 Free relay. The exhibition 400 Free relay team of Coker, Young, DeVantier and Ratterree swam to an easy victory in the final event. Coach Shore's lineup included relay wins by every Vestal senior.

Class A sectionals began on Tuesday with the swimming preliminaries. The diving is being competed at Noon today at Ernie Davis Academy in Elmira. The top 16 in each event from the swimming prelims will move to the championship (top 8) or consolation (9-16) finals on Saturday November 9th starting at 3:30 PM at Watkins Glen. In Class B the undefeated Waverly Wolverines will look to upset Maine Endwell, while Watkins Glen again appears to be the team to beat in Class C.

In each event only the top 16 at finals score team points to determine the sectional team championship. Horseheads will be favored to repeat as champions, but Vestal looks to be in the fight for 2nd place with Corning and Ithaca. A 2nd place finish would be Vestal's highest finish since 1988, as they have finished in 3rd for the past three seasons. Last year they captured five medals, but had no event winners as they fell behind Horseheads and Corning, but ahead of Ithaca. DECISION

For a Use Variance as required by Chapter 24, Article IV, Division 1, Section 24-152, Permitted Uses, of the Code of The Town of Vestal, Broome County, New York (Zoning Ordinance).

At a meeting duly scheduled for October 24, 2024 the Zoning Board of Appeals of the Town of Vestal held a public hearing at 6:31 PM to consider the application of Scenic RE, LLC, regarding premises situate at 4610 Vestal Parkway East, Vestal, NY 13850, B.C.T.M.P.# 159.15-2-2 for a Use Variance as required Chapter 24, Article IV, Division 1, Section 24-152, Permitted Uses, of the Code of The Town of Vestal, Broome County, New York (Zoning Ordinance), pertaining to a property use that is not permitted in a C-2, Community Business District. Appearing in support of the Use Variance request are Sarah Grace Campbell of HH&K Attorneys and Evan Podab of Scenic RE.

Proof of publication of the notice of the hearing in the Press & Sun-Bulletin was submitted, and the Board's letter to the applicants in response to their application was read. The applicant submitted a package outlining the request along with numerous letters, a project summary, survey maps, preliminary site plan, parking plan, SEQR short form, realtor justification report and other exhibits for this property. A 239 1 & m review was submitted to the Broome County Department of Planning and Economic Development and reply's from this department, Binghamton Metropolitan Transportation Study, and NYS Department of Transportation, Region 9.

Board members present, Mark Tomko, Chairman, Clayton Ellis, Jerry Schultz, and Eugene Burns. All Board members stated that they had visited the site and were familiar with the character and nature of the area and this property.

A motion was made by Clayton Ellis to approve a Use Variance to allow the construction of a multi-use residential structure as per Chapter 24, Article IV, Division 1, Section 24-152, Permitted Uses at B.C.T.M.P. # 159.15-2-2 aka 4610 Vestal Parkway East, Vestal, NY 13850 as presented to the Board.

The motion was seconded by Eugene Burns. A vote was called and:

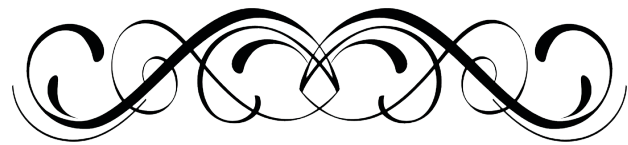

Public Comment on Agenda Items

Christina Pierce, 633 Anderson Road, Vestal - Questioned the difference between the wording of the resolutions for the Girls' Ice Hockey Merger vs. the Boys' Ice Hockey Merger.
