ance will be the revocation or suspension of credit card privileges, and action to compel repayment of charges and administrative fees.

- 6. In cases of misuse or failure to follow policy by an elected official, the Town Board will address the issue through public review. Instances of non-compliance will be documented in Board meeting minutes, and the official may be required to reimburse the Town for any unapproved charges. Severe misuse or a failure to reimburse the Town for any charges or costs to the Town made in violation of this policy may also lead to criminal prosecution.
- 7. If an elected official fails to adhere to this policy, the Town Board may revoke or suspend their credit card privileges by majority vote, ensuring accountability while respecting the official's elected status.
- 8. All instances of non-compliance or misuse, including disciplinary actions taken, will be documented by the Town Board to ensure transparency and accountability.

E. Audit and Review

- 1. All receipts must be itemized and reconciled with credit card statements.
- 2. Each purchase must include documentation of purpose unless the purpose is readily
- apparent. Users must be able to provide documentation to clarify the purpose if requested.
- 3. The Town Board will audit all credit card purchases monthly, confirming compliance with procurement policy.
- 4. Discrepancies must be resolved immediately by the cardholder.
- F. Security
- 1. Cardholders must report lost or stolen cards immediately; failure to do so may result in

disciplinary action.

- 2. The Town Board or its designee will periodically review card activity.
- 3. The Town Board will maintain a master list of all issued cards and update it annually.
- 4. Cards must be securely stored when not in use.
- G. Separation from Employment or Office

Before leaving employment or office, a cardholder must return their Town Credit Card, which

will be immediately deactivated.

The statement of unpaid sewer rents for re-levy were given to the Board for the Towns of Windsor \$47,300.68 and Kirkwood \$6,294.97 totaling \$53,595.65 which will be forwarded to the County for the tax bills.

Attention Private Employers: Paid Prenatal Leave Began January 1st, 2025

Beginning January 1, 2025, New York's Paid Prenatal Leave law went into effect. This first-in-the-nation law will require private employers to provide pregnant employees with 20 hours of paid prenatal leave, ensuring that pregnant employees can take time off for medical appointments related to pregnancy without the fear of losing income.

Paid Prenatal Leave is applicable to both full-time and part-time employees.

Pregnancy-related health care includes physical examinations, medical procedures, monitoring, testing, and discussions with a health care provider related to the pregnancy.

This personal leave time may be taken in hourly increments, and compensation provided must be at the employee's regular rate of pay or the applicable minimum wage, whichever is greater.

Employers are not required to pay an employee for unused prenatal personal leave at the time of separation from employment.

With Paid Prenatal Personal Leave, businesses can help expectant workers focus on their health needs without financial worry while providing them with the peace of mind that comes with knowing they work in a place that puts their needs first.

Everyone should be able to access the care they need, especially when they are expecting. Paid Prenatal Leave is another shining example of how New York State and New York State businesses are committed to supporting the health and safety of all workers.

REMINDER: New York State Minimum Wage Increased On January 1st

Governor Kathy Hochul has announced that on January 1, New York's minimum wage will increase to \$16.50/hour in New York City, Westchester, and Long Island, and \$15.50/hour for the rest of the state. Raising New York's minimum wage to keep pace with inflation will benefit hundreds of thousands of minimum wage workers across the state.

"In this current era of inflation and rising costs, every cent counts for all New Yorkers, especially workers who earn the minimum wage. By gradually increasing wages for the lowest earners, we are ensuring businesses can adjust to the change while also helping more families make ends meet," said NYSDOL Commissioner Roberta Reardon.

This increase is the continuation of the historic multi-year plan to increase the minimum wage to 2027 and beyond. Looking ahead, the minimum wage will increase by \$0.50 in 2026. In 2027, it will increase annually at a rate determined by the Consumer Price Index.

The Windsor wrestling program is hosted the 67th Annual Windsor Christmas Wrestling Tournament, the oldest wrestling tournament in the state on Friday, December 27th, and Saturday, December 28th at Windsor Central High School.

This year's tournament featured 41 teams from New York, Pennsylvania, and Virginia, including Amsterdam, BGAH, Blue Ridge, Burnt Hills, Cazenovia, CBA/JD, Chenango Forks, Copenhagen, Corning, Deposit, Fairport, Gouverneur, Greene/Oxford, Homer, Honeoye-Falls Lima, Horseheads, Indian River, Ithaca, Johnson City, Lansing, Lowville, Manhasset, Marathon, Newfane, Norwich, Sackets Harbor, Saratoga Springs, Southwestern, Spencer-Van Etten/Candor, St Francis, Susquehanna Valley, Tioga, Towanda (PA), Union Endicott, Walton/Delhi, Waverly, Wellsville, and Windsor.

Dozens of state place winners and a handful of New York and Pennsylvania state champions are part of this year's tournament.

"The Christmas Tournament has long held the tradition of attracting the toughest competition. Many athletes go on to place and win at the highest levels of the sport thus making the event 'The Tournament of Champions," said Windsor wrestling coach Jeff Nolan.

Friday's schedule featured a special appearance by former Windsor wrestling coach Jim Howard, who founded this tournament in 1957. It's the first time in over a decade that Howard has visited the tournament

"This school wasn't here (when we started). We were down below," said Howard. "Jeff (Nolan) gave me a tour the first time I came back. It's good to see."



Governor Hochul Announces New CDPAP Partnership With **Independent Living Centers as Part of Plan to Strengthen Home Care Services for New Yorkers**

Governor Kathy Hochul today announced that New York State and Public Partnership LLC (PPL) are partnering with 11 Independent Living Centers (ILCs) as part of the State's plan to strengthen the Consumer Directed Personal Assistance Program (CDPAP) for New York's home care users. New York's ILCs are among more than 30 community-based partners who will work closely with PPL to ensure the CDPAP program continues to deliver high-quality home care services for New Yorkers, including a successful transition by April 1. Governor Hochul also highlighted that CDPAP consumers across New York can now begin registering with PPL to ensure their continued service as part of this transition process.

"Our statewide partnership will protect CDPAP and ensure continued access to high-quality home care for New Yorkers across the State," Governor Hochul said. "I'm pleased that independent living centers will play an important role as partners in this effort, as we create a better and stronger CDPAP for home care users and caregivers."

State Health Commissioner Dr. James McDonald said, "This is an important next step in our transition. Through this collaborative network of independent living centers, community-based providers and Public Partnerships LLC, we are ensuring the future of CDPAP for generations to come. New York State is demonstrating our ongoing commitment to protecting those who are served by this program."

Town of Colesville Offices

The Town of Colesville lies in the northeast part of Broome County and is bounded on the north by Chenango County, on the east by the Town of Sanford, on the south by the Town of Windsor, and on the west by the Towns of Kirkwood and Fenton. The town was formed on April 3, 1821, from the Town of Windsor. Harpursville is the largest hamlet in the town although it is not incorporated.

Colesville derives its name from pioneer Nathaniel Cole, a revolutionary soldier. He settled here in 1795, on a hill south of Harpursville, known as Coles Hill. He built a tavern there which was in operation as early as 1800. It was the first tavern between Albany and Binghamton. Broome County's Nathaniel Cole Park was opened in the town in 1974 and is located about two miles from the site of its namesake's tavern.
