

By: David Glaser, AuD., CCC-FAAA HOW DOES SURFER'S EAR AFFECT HEARING?

Surfer's ear is the common name for a condition caused by repeated exposure to cold water and wind. Also called external auditory canal exostosis (EACO), it's not limited to surfers and can affect open water swimmers, kayakers, and anyone regularly exposed to cold water. EACO causes a bony growth inside the ear that can take 10 to 15 years to form. The growth itself isn't harmful, but it can cause recurring ear infections and hearing loss and trap water inside the ear, leading to additional problems. Once the condition is discovered it may be treatable with eardrops and antibiotics but can also require surgery. The best way to prevent surfer's ear is by wearing earplugs when exposed to cold water.

Tip of the week:
One of the best ways for your hearing healthcare provider to determine if there is an obstruction of the ear is to perform otoscopy of the ear as well as to have a comprehensive performed




