County Kicks Off The New Year With Winter Storm

2024 Marks 30-Year Anniversary of 1994 **February Ice Storm**

Towards the end of last week, County Officials and the National Weather Service issued alerts about an approaching significant winter storm.

Initially expected to bring only light snow, the weather's forecast was unpredictable to say the least. Starting Sunday night, Tishomingo County experienced heavy sleet, later transitioning into a mix of light sleet and snow. The already belowfreezing temperatures prior to the sleet set the stage for a difficult week ahead. By Monday morning, a thick blanket of snow covered the area, hiding a dangerous layer of ice underneath, which led to extremely hazardous road conditions. The snow and sleet continued intermittently throughout Monday, worsening the situation. In some areas, snow accumulation reached up to 10 inches.

By Tuesday, despite the precipitation having passed, road conditions seemed to have deteriorated further in some areas. Sunlight caused the snow and ice mixture to partially melt and then refreeze later at night, eventually forming thicker sheets of ice instead of completely melting away, as outdoor temperatures remained well below freezing. These temperatures are some of the coldest consistent readings in this part of Mississippi since 1989.

It should be noted that this year's winter storm arrived

on the 30th anniversary of a significant event that occurred February 10th, 1994. the Ice Storm or "the Big Chill" as some have called it. The Ice Storm caused widespread disruptions to power and water services across Tishomingo County and neighboring areas. The 1994 storm affected approximately 160,000 people in northern Mississippi, disrupting water and power for at least 9.000 Tishomingo County residents. On February 20th, President Bill Clinton officially declared Tishomingo County one of many disaster areas and was cleared to receive disaster relief assistance to help the county bounce back.

While the recent storm did not reach the severity of the 1994 event, it mirrored some of the same challenges, especially with ice making many roads impassable, leading to a temporary shutdown of many services throughout the county.

Despite the conditions, no major accidents were reported as a result of the weather. Residents found ways to enjoy the snow, spending time with family and friends. Local businesses, such as Busby Excavation LLC, aided in de-icing and clearing roads and parking lots across the county.

We extend our thanks to TCEPA and city workers all over the county, from Belmont to Iuka, for their efforts in maintaining vital infrastructure during these cold times.

Timely Response Leads to Good Outcome for Helton

Kathy Helton has become "forever friends" with the ambulance crew who responded to her home in October 2023.

"That morning, I walked to the kitchen to fix coffee, and I felt funny," Helton says. "I just went out. I couldn't talk or think. I didn't know anything after that, but apparently I fell, and my husband called an ambulance."

Paramedic Regina Kennedy and EMT McKeel Brittany rushed Helton to North Mississippi Medical Center-Iuka. "I am so indebted to them because they were paying such close attention to my symptoms," Helton I needed CareFlight to fly me to (North Mississippi Medical Center in) Tupelo right away. I feel like they saved my

Doctors determined that multiple blood had traveled from Helton's leg to her lungs, heart and brain, causing a stroke. Because of the crew's quick action, Helton arrived in Tupelo in time to receive tPA (tissue plasminogen activator) to break up the clots.

Neurosurgeon Dr. Jason Stacy performed emergency surgery—a cerebral endovascular thrombectomy--to remove the blood clot

says. "They knew that from her brain and restore blood flow.

Once able, Helton transferred to NMMC's Rehabilitation Institute for physical, occupational and speech therapy. Back home, she followed up with Outpatient Rehabilitation at NMMC-Iuka. She has now regained full range of movement and speech and, except for tiring more easily and a little difficulty with writing, Helton is back to her old self.

The magnitude of what happened isn't lost on Helton, and she made sure to thank the two who got her to the right care in the nick of time. "I thoroughly love them," she says.



Looking back a few years I Remember by Ruth Dawson



This photo from our files a few years back shows Front Street covered in snow with only two pickups in town. Probably made in the late 1970's, you can see Daisy's House of Fashions (now Friendly Florist), Tom Aker's Cab Stand, the Snack Bar, Moore's Jewelry, Rushing Drugs and Cozy Corner. At the end of the street vou can see Grisham's Men's Wear.



Eastport Street, maybe before the 1970's, across from luka Baptist Church. Building at left is now a parking lot, then there was Mr. Crossett's office and at one time this little building was the luka Library, then next is Strutt Edmondson's dry cleaner (Apron Museum today), The Vidette was also in this building in the 1950's. This was called the Dexter Block.

Here is your old Scribbler of "I Remember". I feel compelled to write about my experiences with my niece, Carolyn Jewel Edmondson Southward, daughter of Jewel Page Edmondson and Dorlan Ditman Edmond-

I had just graduated Tishomingo High School and enrolled in correspondence courses, Freshman English and General Psychology. No teaching license! At graduation in 1944, Mr. O.J. Eaton, our County Superintendent of Education in Tishomingo County was on the stage that night. After graduation ceremonies he asked me if I would teach that year at Cripple Deer, a one room, one teacher school. This was the school where I had spent ten years: Primer, First Grade, 2nd grade, and two years in Grade "3". My Mom had taught there before she and Dad married. At that time if you were married, it was like the nursing profession, they only wanted a single lady. I had wanted to become a nurse. The School of Nursing didn't take young married ladies. (I only wanted to be a nurse when I was growing up so I could wear those cute little white caps!) Smile

I said, "yes, Mr. Eaton, I'd love to teach at Cripple Deer." I had married Chester N. Dawson on August 4, 1943, before graduating in 1944. I was nineteen, Chester had gone to the Army, drafted, another story. I walked from where I lived on David "Dee" Dawson hill through the woods to Cripple Deer School. My walk down Old Highway 25 to Mr. Allen Johnson's

home and took a road, that at that time, ran from highway 25 over to the Mt Glory Road where it ended. Mom and Dad lived where this road of about 1 1\2 miles ended at their home.

Carolyn's Dad was over-seas in the "heat" of World War II. Jewel had been with him while he was in Basic Training in Florida and the last training was at Camp Shelby in Hattiesburg. They lived with a couple of Senior adults and kept house for them to pay for their rent. When this tour of training was over he was sent over-seas where he and a team set up a communications system ahead of the oncoming Army. Jewel mad friends that had a room with the same couple. Sarge and his wife and they stayed friends by mail for several years.

It was 1944, and Jewel came home to live with Mom and Dad and our siblings. She was expecting a baby and Dorlan was in the war. Carolyn was born October 11th! I walked as fast as I could go to get to their house so I could hold Carolyn a few minutes before I headed to. Cripple Deer to teach. The school was composed mostly of my sisters and first cousins. There were only 12 children to teach. I taught! We learned - students as well as teacher, but it was a very good vear for me. I felt very much at home!

Carolyn grew that year to smile and kick for joy when I would run in each morning. She was mine for ten to fifteen minutes! After the school ended Jewel would let us come and get she and Carolyn and visit regularly until Dorlan came home.

I was young, Chester had been discharged from for Bragg, NC. He had pneumonia when he was 16 and almost died. It had left scars on his lungs. He was sent to North Carolina and trained outside in a cold wet area where he got pneumonia and was in the hospital for 21 days. He wanted to go back to his company.

The Captain told him he couldn't go back. Leslie Cox from north of Iuka, I believe, moved up to where Chester served. He told Chester when the war was over he was glad he was sent home. The one who fill his "slot" was killed. We lost so. Many of. Tishomingo Countians. When you pass a listing of these brave boys who gave their "all" to keep us free, stop and read their names and thank God for our freedom! It is because of the young men and women who loved freedom and our wonderful country, America, the country God has had his Hand on since 1492.



Carolyn loved America! She gave, and she served her community! Carolyn Jewel Edmondson Southward will be missed by her husband H.O., sons Bryan and Jason, and her pride and joy grandson Brayden! She loved her family, church, friends and was a super-female fire fighter! We honor and cherish her memory!
