The City of Wayne will be accepting sealed bids for the razing of two structures (house and detached garage), including basement and all footings, and general grubbing of trees and bushes along the south and west sides of property, located at 330 South Main Street, Wayne, Nebraska. Bids will be received until 4:00 p.m. on Thursday, October 12, 2023. The following criteria should be included or noted by the Contractor when submitting the bid:

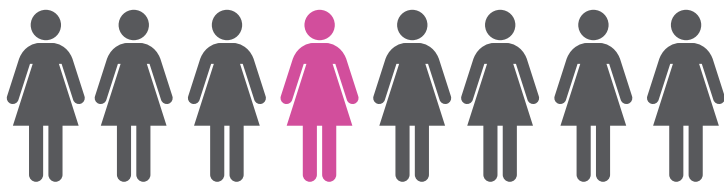
- Demolition shall be completed by November 30, 2023

- Demolition materials must be taken to a licensed landfill
- Contractor shall have salvage rights to materials
