

CITY NOTICE

The Wayne Public Works Department wants to remind all residents that blowing lawn mower clippings into the street is prohibited and is a violation of City Code, Section 78-237. These grass clippings and other such debris left on the street will travel to the storm sewer inlet and can block them. The blocking of the inlets can cause local flooding from storm water accumulation.

Because the water from the storm sewers runs into Logan Creek, the grass clippings can negatively affect the creek with the chemical content in the grass from lawns that have been fertilized and treated with weed killer.

When mowing, please mow the first few rounds so that the grass blows in towards the lawn and when finished, sweep up the grass that has been thrown into the street.





GENERAL NOTICE YOU ARE REQUIRED TO CONTROL NOXIOUS WEEDS ON YOUR PROPERTY

It shall be the duty of each owner, owner's agent, and occupant of any lot, tract or parcel of land in the city to cut and remove from such lot, tract, or parcel of land, together with half of the abutting streets or alleys, excessive growth of weeds, grasses or worthless vegetation. Such growth shall be cut as close to the ground level as possible and shall be maintained as close to the ground level as possible throughout the period of May 1 to October 15 of each year. Growing or permitting the growing of weeds, grasses, or vegetation in violation of this subsection is a nuisance and is prohibited.

It shall be unlawful for any owner, owner's agent or occupant of any premises described in subsection (a) of this section to allow to grow or to maintain any weeds, grasses, or worthless vegetation 12 inches in height or greater.

The City Administrator or his or her designee shall cause to be published in a legal newspaper of general circulation throughout the city for one time at least ten days before May 1, and on any other date designated by resolution of the council, a general notice to owners, owner's agents, or occupants of real estate within the city to cut and remove excessive weeds, grasses and worthless vegetation 12 inches in height or greater from such premises. The notice shall specify that the weeds and other rank growth of vegetation shall be cut as close to the ground level as possible throughout the period of May 1 to October 15.

The City Administrator or his or her designee is authorized and empowered to notify, in writing, the owner, or owner's agent, and occupant of any such lot, place or area within the city to cut, destroy and remove any such weeds, grasses or worthless vegetation 12 inches in height or greater located on such property.

Within five days after receipt of such notice, the owner or occupant of the lot or piece of ground may request a hearing with the City to appeal the decision to abate or remove a nuisance by filing a written appeal with the office of the City Clerk. A hearing on the appeal shall be held within 14 days after the filing of the appeal and shall be conducted by the City Administrator. The City Administrator shall render a decision on the appeal within five business days after the conclusion of the hearing. If the appeal fails, the City may have such work done.

If the owner or occupant of the lot or piece of ground does not request a hearing with the City, or upon the failure of any such owner, owner's agent, or occupant so notified to cut, destroy and remove such weeds, grasses or worthless vegetation 12 inches in height or greater within five days after receipt of notice provided for in subsection (d) of this section, the City may have such work done. The costs and expenses of any such work shall be paid by the owner.

If the costs and expenses mentioned in subsection (f) of this section are unpaid for two months after such work is done, the City may either (i) levy and assess the costs and expenses of the work upon the lot or piece of ground so benefited in the same manner as other special taxes for improvements are levied and assessed or (ii) recover in a civil action the costs and expenses of the work upon the lot or piece of ground.
